Lindenhurst High School – May 31, 2018 - Prom Contract Seniors Only Attending LHS – The Crescent Beach Club

The 2018 Lindenhurst High School Prom promises to be a fun and exciting event. Great effort and many hours have gone into the planning, preparing, and setup of this year's Prom in hopes that it will be a special occasion for all our students and their guests. The LHS Class Council, their advisors, and the high school administration hope that you enjoy your evening. In order to ensure everyone's enjoyment, there are several guidelines that we expect all students and guests to honor. Failure to abide by these guidelines will result in immediate removal from the Prom and other disciplinary actions as deemed necessary by school administrators and the Lindenhurst School Board Code of Conduct.

Before any senior purchases a ticket, this form (front & back) must be completely filled out and signed.

This is a contract!!

Please read it carefully.

The Prom will begin at 6:00 pm, May 31st, at The Crescent Beach Club; 333 Bayville Avenue, Bayville.

Student Prom Contract Guidelines

- Prom tickets are \$90.00 per person.
- The last day to purchase a Prom ticket will be **Friday, May 4, 2018**. ***There are no exceptions.***
- I am aware that any suspension of five days or more will revoke this contract.
- All students will continue to satisfy their academic requirements the day of the prom.
- All students must attend periods 1 through 5 on May 31st.
- You must arrive to the Prom by 8:00 pm or you will not be permitted to enter.
- No tickets will be sold at the door. We will maintain a list of ticket holders and no one will be admitted who is not on the list.
- All Prom attendees will refrain from the consumption of alcohol or the use of any illegal drugs on the day of the Prom. Any student found to be in possession of or under the influence of any type of alcohol or illegal drug will be disciplined under Lindenhurst Board of Education Code of Conduct and NYS Law. The student(s) will be asked to leave the Prom in the company of his/her parent or guardian, and will be suspended from future school-related activities which may include graduation.
- This is a smoke-free Prom.
- If a senior's guest is another LHS student (grades 9-11) or a student from another school, the guest must fill out a guest contract with parent signatures. A copy of the guest's driver's license or school ID is required at the time the bid is purchased and the night of the prom.
- All Prom attendees will conduct themselves in a polite, courteous, and respectful manner.
- All Prom attendees will demonstrate respect for other Prom attendees, Prom supervisors, security personnel and both The Crescent Beach Club personnel and facility. Failure to do so will result in your removal from the Prom.
- Prom attendees who leave the Prom without supervision will not be allowed to re-enter.
- I / we have read the 2018 Lindenhurst High School Prom Contract and agree to abide by the guidelines outlined above. I / we understand that my / our failure to abide by these guidelines will result in my / our immediate removal from the Prom. LHS will make no refunds of any kind.
- I understand and will comply with any test required on site to show I am not under the influence of alcohol.
- In order to purchase a Prom bid you must have your completed contract (guest contract if applicable, including a copy of driver's license or student ID)

PARENT CONTRACT:

I agree with the school rules concerning the Prom and will give my parental cooperation for the following:

- I will not serve alcoholic beverages before the Prom to Lindenhurst High School students and their guests.
- I will remind my son/daughter that once he/she enters the Prom, he/she will not be permitted to leave the Prom for any reason. Once my child leaves, he/she may not return to the Prom.
- Prom runs from 6:00 pm to 10:00 pm. Students must enter the building no later than 8:00 pm. Any students/guests who arrive after 8:00 pm will not be allowed to enter.
- I understand that my son/daughter may not attend this event unless this form is filled out completely and presented at the time of purchase. I further understand that a parental signature is required even though the student may be eighteen years of age. I understand that student guests from other schools must complete an additional contract.
- I understand that my son/daughter may be tested at the Prom for the presence of alcohol if suspected of being under the influence.
- I understand if my son/daughter is suspected of being under the influence of drugs or alcohol, I will be contacted and am responsible for picking them up.
- I understand that there are no refunds.
